13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Our goal will be to keep injured and struggling Florida veterans housed by helping them maintain their current homes, build or modify homes, or help displaced veterans with temporary housing. With \$1 million, we would help a minimum of 20 injured veterans and their families. We'd also help as many as 60 veterans and 200 family members with team building, physical health and mental wellness programs, and 50 veterans with emergency funding. In addition to helping these families, we plan to invest an additional \$2,500,000 for a return of investment to the State of Florida of at least \$3,500,000 -- a 3.5:1 return.

b. What activities and services will be provided to meet the intended purpose of these funds?

Building Homes for Heroes has a vast network of veteran applicants exceeding 5,000 who are currently asking for our help. Home projects will focus on keeping veterans housed, including helping veterans with mold remediation from water damage, mortgage payments, taxes, home repairs caused by storm damage, temporary housing expenses for displaced veterans, utilities, insurance deductibles, home modifications to increase accessibility and gifting homes when feasible. We'll also host a massive 3-day, 2-night Team Building event in Orlando in May to support 60 veterans and 200 family members. Last, we'd provide emergency funding to 50 veterans in the state of Florida through our emergency funding program.

c. What direct services will be provided to citizens by the appropriation project?

We will prioritize injured Florida veterans who are struggling with their physical and mental injuries and who whose lives have been altered by emergencies, economic struggles, weather-related disasters, and any difficulties they already face transitioning from military to civilian life, including but not limited to mold remediation from water damage, mortgage-payments, taxes, home repairs caused by storm damage, temporary housing expenses for displaced veterans, utilities, insurance deductibles, home modifications to increase accessibility, and gifting mortgage-free homes for injured veterans to own, live in and recover in. We'll also host a massive 3-day, 2-night Team Building event in Orlando in May to support 60 veterans and 200 family members. Last, we'd provide emergency funding to 50 veterans in the state of Florida through our emergency funding program.

d. Who is the target population served by this project? How many individuals are expected to be served?

The most direct benefactor will be the hundreds of Florida veterans for whom we will be helping with home repairs, team building, physical health and mental wellness programs and emergency funding. Additionally, their immediate family members whose lives are also severely affected by the struggles veterans endure, will also directly life-changing impact. Furthermore, hundreds of Florida residents, including contractors and vendors will also see a benefit as a result of economic advancement through increased employment opportunities, elevated property values and improved infrastructure.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The methodology will be the number of veterans we help with housing. We will aim to help a minimum of 20 Florida veterans and their families gain or maintain housing with a return on investment of at least \$3.5 million to the State of Florida. The methodology will be the return on investment we bring to the Florida economy, as well as the return on life we will provide to continue our mission to build better and brighter lives for our injured veterans.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

We would recommend the same penalty from previous years' grant requests: With our plan to help a minimum of 20 veterans with housing, we recommend a penalty of \$40,000 per veteran we fail to help. But with the hope of helping more than 20 veterans, please know we have every intention of fulfilling all of our contract obligations.
