Stranahan House holds significant historical importance as the oldest remaining structure in the city. Build in 1901 by Frank and Ivy Stranahan, a businessman, first teacher, and early settlers, the house originally served as a community center. They played a crucial role in the development of the city. The museum reflects its Native American roots and growth of the region in the 20th century.

c. What direct services will be provided to citizens by the appropriation project?

Stranahan House complies with Sunshine State Standards by serving as an educational resource that aligns with Florida's history and social studies curriculum. The museum offers students a hands-on experience with local history, including early settlement, Native American culture, and the development of Fort Lauderdale. It provides learning opportunities in line with state standards for history.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target populations to be served by this project are at-risk youth, developmentally disabled and physically disabled individuals, grade school students, and high school students. We expected over 800 individuals to be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

We expect an improvement in quality of education. We will measure this through a comprehensive internal spreadsheet that tracks all the schools that schedule and participate in field trips, comparing spreadsheets from previous years to show the large increase of students on property. We will also increase economic activity by generating more revenue from the use and rental of the upgraded, ADA-compliant facilities and newly developed indoor and outdoor spaces which will be measured in our annual audit. We can also expect to see a year-over-year increase in tourism measured through our ticketing system, showing reports of increased ticket bookings. Once there is more activity on our property, we will be able to hire new part-time employees to help manage programs, creating job opportunities for local citizens, measured by our 990s.
