4. Project/Program Description

The North Florida TPO LRTP and Nassau County's Comprehensive Mobility Plan identify the County Road 108 Extension as a critical link to the County and Regional mobility network. Providing an east-west corridor north of and paralleling SR 200/A1A is critical for Nassau County's transportation network over the next twenty years in anticipation of predicted population growth in the area. The County Road 108 Ext. will provide an alternative corridor for commuters traveling east/west through Nassau. The adopted Mobility Plan identified the importance of the CR 108 Extension in the overall transportation network. The Mobility Plan Study was performed by outside engineering consulting firm Peters and Yaffee.
