It also includes salaries for aged-out youth we hired to work as GHH Camp Counselors and Interns (\$31,250). 13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

This program prepares youth who will not be reunified with family or adopted to successfully transition from the foster care system to a purpose-driven adulthood, independent of public assistance and out of the justice system. The appropriation funds will provide students with a path to graduation, employment, life skills, and independence. 300+ foster youth will receive the wraparound support, resources, and the family environment needed to maintain housing, avoid incarceration, become self-sufficient, complete post-secondary education, and achieve good mental and physical health.

b. What activities and services will be provided to meet the intended purpose of these funds?

We will meet the purpose of these funds through evidence-based solutions, including personalized coaching, stable housing, life skills, connection to community services like therapy, and access to programming via transportation and technology. We will also provide educational and employment readiness programs, including tutoring, vocational and entrepreneurial training, and job creation at Genesis Hopeful Haven and in partnership with community agencies.

c. What direct services will be provided to citizens by the appropriation project?

These funds will provide foster youth with life skills like financial literacy, healthy relationships, and civic engagement and offer educational, enrichment, and career workshops led by knowledgeable staff and community partners. We will provide personalized tutoring, mental health support, behavioral assessments, one-on-one coaching, mentoring, job opportunities, housing, and accountability.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is foster youth ages 10-14, youth transitioning out of foster care ages 15-17, and former foster youth ages 18-25. Most of our foster parents come from low-income to lower-middle-class socioeconomic statuses, and 85% of our students have mental health disorders, including autism. They are some of the community's most vulnerable residents who have experienced neglect, abuse, physical, mental, and sexual violence, human sex trafficking, and separation from their siblings, all of which can be gateways to involvement in the justice system without Genesis Hopeful Haven's comprehensive intervention, diversion, and prevention programming. Approximately 300 students in this target population will be served. (Persons with poor mental health, Jobless persons, Economically disadvantaged persons, Atrisk youth, Homeless, Grade school students, High school students, University/College students, Currently or formerly incarcerated persons, Victims of crime)

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Expected program outcomes include improving physical and mental health, education quality, and housing access, as well as creating immediate job opportunities, enhancing economic self-sufficiency, and diverting foster youth from the criminal/ juvenile justice system. We track outcomes through frequent data collection to assess impact, including school report cards, attendance records, and feedback and testimonials from teachers, school counselors, caseworkers, and foster parents, as well as behavioral charts and social-emotional learning assessments that measure social skills, emotional resilience, and stress management strategies, increased leadership roles are measured by the level of involvement in GHH, school, and home activities, demonstrating the student's ability to take on responsibility and lead others, student meetings, interviews, surveys and assessments to gauge program satisfaction and information retention, and employment status and length, pay stubs, and bank statements.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

We will meet deliverables as we always have with our community partners, including the FL Department of Children and Families. Failure to comply and perform negatively impacts our foster youth the most, which we refuse to do. To ensure our compliance, we have performance benchmarks for Gensis Hopeful Haven staff and conduct internal audits for our programs. We can share this information to show our progress, impact, and outcomes. We also welcome an audit if the State feels we failed to meet agreed-upon measures.
