Activities will include clearing debris from the pond, trimming or removing overgrown vegetation blocking natural drainage, and repairing and improving the stormwater system. These services will enhance water flow, prevent flooding, and improve the overall stormwater management for the facility and surrounding community.

#### c. What direct services will be provided to citizens by the appropriation project?

The appropriation project will provide improved flood prevention, enhanced stormwater drainage, and safer access to the facility for citizens. It will also reduce health risks associated with standing water and protect surrounding properties from water damage

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served by this project includes individuals from Orange, Polk, Hillsborough, Seminole, Osceola, Pasco, Palm Coast, Lake, Sumter, Hernando, Miami-Dade, Pinellas, and Marion counties within an average of 120 individuals served weekly, not including the large neighborhood community surrounding the facility.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

The project will improve stormwater management by enhancing drainage efficiency, reducing standing water, and preventing flooding, while creating a healthier ecosystem. Success will be measured through water flow monitoring, reducing pooling, and increased stormwater system capacity. Debris removal and vegetation clearance within 10 feet of the west shore will improve water quality, restoring natural flow, and support wildlife habitats. Inspections, water level measurements, and rainfall analyses will track outcomes.


