The residents of the City of Sweetwater will benefit from having their own police department to respond to emergencies throughout the city. The Mobile Command Post will augment the Police Department's response to large scale emergencies in the city such as natural disasters, mass casualty incidents, hostage situations, and other situations requiring multi-jurisdictional response.

The City of Sweetwater is a minority-enriched community that is 95% Hispanic, a target population of 51-100 will be expected to be served.

Reduced crime, ability to operate during power outages and/or extreme conditions, augmented patrolling capacity and police presence, more collaborative efforts with other agencies.
