The Public Safety Dock Rehabilitation Project is a strategic, multi-agency public safety asset on the Intracoastal Waterway, serving as a maritime operations hub for the Boca Raton Police Department and Florida Fish and Wildlife Conservation Commission (FWC). The proposed project is to rehabilitate the dock and revetment to restore full operational capacity, secure local and state law enforcement assets, and enhance the safety of Florida's waterways.

Additionally, this area houses two floating docks, several picnic tables, and a nearby kayak launch. These are all accessible to the public and may be revitalized during this project.
