a. What specific purpose or goal will be achieved by the funds requested?

The specific goal of the multi-basin study is to evaluate stormwater management options to alleviate flooding issues in the area that occurs during large storm events.

b. What activities and services will be provided to meet the intended purpose of these funds?

The multi-basin study will include the following:

- 1. Conducting a field investigation to collect information on the drainage network for the different outfall paths within the designated multi-basin service area.
- 2. Creation of an existing conditions model to understand current flooding issues, an analysis of the results will show bottlenecks and other issues in the existing drainage system.
- 3. An efficiency analysis will identify potential solutions to the drainage system and/or provide recommendations to maintain the existing system.
- c. What direct services will be provided to citizens by the appropriation project?

By completing the multi-basin study, Brevard, FDOT, and the City of Rockledge will better understand the costs associated with the design and construction of the improvements to mitigate flooding occurring after large storm events. The flooding currently occurs over roadways and within private residential properties in the region.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population to be served by this project will be the residents of the immediate area. Approximately 1000 individuals are expected to be served by the improvements.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The multi-basin study will aid the County, FDOT and the City of Rockledge in determining costs to alleviate flooding across roadways and residential properties therefore improving the water quality flowing through to the different outfall paths within the designated multi-basin service area

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

The County's contracts for engineering services include comprehensive provisions that address the standard of care required for professional services, quality control, and timeliness. The contracts include provisions that address dispute resolution, failure to perform, and termination. The County will complete a post-project evaluation of the consultant and submit the form to the County's Purchasing Services.
