4. Project/Program Description

With the highest number of pedestrian crashes in Miami-Dade County, Little Havana has seen a 160% increase in crashes over 5 years—from 145 crashes in 2020 to 386 in 2025, resulting in 284 injuries and 18 deaths. In response, Miami-Dade County has partnered with the City of Miami to transform pedestrian safety around one at-risk Little Havana school, Citrus Grove K-8 Center at 2121 NW 5th St, Miami, FL 33125. Thanks to State and local funding, Phase 1 improvements are delivering critical safety improvements along NW 22nd Ave., NW 6th St., and NW 3rd St. Phase 2 funding will complete this life-saving initiative by converting NW 3rd Street and NW 19th Avenue into a safe corridor, creating protected pathways that allow children to walk to school without fear in this working-class neighborhood. The project includes safer intersections, enhanced lighting, improved sidewalks, high-emphasis crosswalks, protective street trees, and integrated stormwater management.

13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The funds will be used to design and construct pedestrian safety projects and essential stormwater improvements around Citrus Grove K-8 Center to make it safer for the children who attend the school, many of whom walk to school, and to reduce the number of pedestrian crashes, injuries, and fatalities.

b. What activities and services will be provided to meet the intended purpose of these funds?

Sidewalks will be constructed where none exist across the street from the school entrance. Crossing distances will be shortened with curb extensions. High-emphasis crosswalks and stop signs will increase pedestrian visibility for drivers. Trees will be planted every 30 feet, and sidewalks will be level (instead of sloped as is the current condition), to make it more comfortable for children to walk. Underground drainage will be upgraded. Street lighting will be upgraded.

c. What direct services will be provided to citizens by the appropriation project?

Primary services include roadway safety for children walking to and from school, as well as stormwater upgrades. Citizens will have fewer collisions with cars, fewer injuries and fatalities, and a reduction in roadway flooding. Crash data from 2015-2019 compared to 2020-2025 showed a decrease in crashes at two Little Havana locations where similar safety improvements were implemented near Miami Senior High School and Jose Marti Park.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served are children and families attending Citrus Grove K-8. 1,337 students attend the school.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected outcome is fewer pedestrian collisions, injuries and deaths, and reduced flooding on roadways. There were 18 fatalities between 2020 and 2025, and 284 injuries according to Signal 4 crash data. Signal 4 collects crash data monthly, and this data will be used to measure outcomes.
