Funding is being requested to construct design features that will make the road safer for pedestrians, bicyclists, and motorists. This project is for an approximate 0.48-mile stretch of SW 82 Ave, within Village Right of Way, between SW 160 St and SW 152 St. Improvements include: removal of existing striping and installation of new roadway & bike lane signage along the corridor; reducing the existing travel lanes to 10-ft wide; and constructing slight widening of the asphalt pavement to accommodate 4-ft-wide bike lanes and 1-ft buffer on each side of the road, as per FDOT Standard Index 711-002.

Motorists, pedestrians, and bicyclists who travel the area will benefit from safer road conditions and improved traffic flow.

The target population includes residents of North and South Miami-Dade County who use the road regularly.

The expected outcome of this project is to improve transportation conditions for all pedestrians, bicyclists, and motorists traveling through SW 82 Avenue by providing safer and more favorable transportation conditions. This outcome will be measured by documenting the decrease of accidents on SW 82 Avenue from SW 160 Street to SW 152 Street, quantifying the amount of people utilizing roadways, paths/sidewalks, and bike lanes, and recording the number of traffic complaints received by Village Hall.
