The purposes of these funds are to provide technology for the at risk youth we serve in order to better enrich their education, to increase the educational materials we are able to provide the students, and to purchase a van to assist in transportation for the students. Technological inequities and transportation challenges jointly affect underserved students, especially in rural and low-income communities. Research shows that access to education depends on the intersection of digital inclusion and mobility equity.

b. What activities and services will be provided to meet the intended purpose of these funds?

We would like to provide chromebooks for the students to be used during the day, so they may each access to our online reading and math learning tools during the school day, allowing them to move at their own pace as they find their own learning style. We would also like to purchase a new van to be able to provide daily pickup and delivery services for the students.

c. What direct services will be provided to citizens by the appropriation project?

We will be providing device loans to our students in the form of chromebooks as a means of addressing technology inequities within our community. We will also be providing our students with access to customized math and reading tools, which act as companions to our curriculum, to help address the literacy disparities faced by our youth.

d. Who is the target population served by this project? How many individuals are expected to be served?

Target Population Includes: Economically disadvantaged persons; At-risk youth; Grade School Students; High School Students; Attention Deficit Disorder; Attention Deficit Hyperactive Disorder; Slow Learning Disability We are able to serve a maximum of 146 students, with an average of 50-60 students served annually. Our goal with these funds is to provide technological aid and literacy aid to approximately 51-100 individuals.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected outcome of this project is increased competency in reading and math, as well as an improvement in attendance. Improvements in reading and math competency will be measured by comparing the pre and post assessment scores of each student at the beginning and end of the year. Improvements in attendance will be measured by comparing student monthly attendance ratios throughout the year, with an anticipated steady increase in monthly attendance by all students participating, as well as increase the number of students we are able to serve due to a lack of steady transportation.
