### 13. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The funds will enhance storm resiliency by paving eroded dirt segments and resurfacing damaged paved segments across three roadway sections (0.49 miles) impacted by Hurricane Helene. Severe rutting and standing water previously blocked emergency access and resident evacuation. These improvements will ensure safe, reliable, routes during future storms.

b. What activities and services will be provided to meet the intended purpose of these funds?

Activities include paving eroded dirt segments, resurfacing damaged paved segments, grading and stabilizing roadbeds, and improving drainage to prevent washouts. These upgrades will restore safe access for residents and emergency services, strengthen storm resiliency, and maintain critical routes during severe weather.

c. What direct services will be provided to citizens by the appropriation project?

The funding will provide paved and resurfaced roads, improved drainage, and stabilized roadbeds to ensure safe, reliable access for residents and emergency services. These upgrades will reduce flooding impacts, maintain critical routes during storms, and strengthen community resiliency.

d. Who is the target population served by this project? How many individuals are expected to be served?

Citizens of Greenville (approximately 780 residents), and those traveling through the Town of Greenville.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Improved road accessibility during and after severe weather; faster emergency response times; fewer incidents of vehicle damage from poor conditions; and increased efficiency in maintenance and public works due to dependable roads. Methodologies by which to measure these outcomes include: track the number of days roads remain open during and after severe weather; compare historical and current average emergency response times; collect and analyze municipal and resident vehicle damage claims linked to road conditions; and track the number of completed maintenance and public works tasks monthly.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

If appropriated, the Town of Greenville will ensure that all deliverables and performance measures set forth in the funding agreement are met. These measures will include engaging a compliance/project maintenance team to work with Town staff to oversee administration and compliance of the appropriated funds.
