Funds will be allocated for the replacement of an outfall segment at SW 34th Court and SW 24th Ave, and installation of a new outfall at SW 34th Court and SW 26th Terrace - both outfalls discharge into the same basin. This project is located in a residential corridor and an industrial area with commercial warehouses and businesses. Due to aging and insufficient stormwater infrastructure, the neighborhood experiences frequent localized flooding during moderate to heavy rainfall events, with conditions that disrupt daily life and pose significant risks to public health and safety.

The contractor will mobilize construction crew and replacement and install the modern stormwater infrastructure.

The project will provide improved flood protection, better stormwater management, and enhanced resilience to heavy rainfall, benefiting public safety and property values.

The target population includes residents, businesses, schools, churches, law enforcement, and visitors in the impacted drainage area, with over 5,000 estimated individuals benefiting directly from reduced flooding and improved drainage.

The expected outcomes include reduced flooding incidents, enhanced water quality in the receiving water body, and increased community resilience. These will be measured through pre- and post-construction flooding data, water quality monitoring, and feedback from our affected residents and businesses.
