This project will provide flood prevention improvements as well as better water quality around Gulfview Ridge and Florida Oaks Subdivisions within the City, also known as the Ross Property area. This area experiences flooding mostly due to a lack of adequate drainage conveyance within the ditch. The total cost of design and construction is \$3,416,637. The City is requesting \$1,708,318.50 in State Appropriations Funding (50%) with the City providing \$1,708,318.50 (50%) in matching funds. The City's match would include all of the design costs and half of the construction cost.
