\$1,500,000 requested funds will be dedicated to critical dementia-specific care delivered in Specialized Alzheimer's Adult Day Care Centers licensed pursuant to FS 429.918. \$500,000 will be dedicated to repairs and renovations for existing and new centers to keep loved ones in a safe therapeutic environment. The average age of participants is 80.5 years, with 75% scoring as severely cognitively impaired. Nearly all participants are eligible for nursing home placement. The goal of this funding is to offer a safe, therapeutic environment through a five-day-per-week, full-day program, enabling individuals to remain safely in their homes and communities.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

ACC's day care centers, licensed under the Specialized Alzheimer's Day Care Act (FS 429.918), are held to a high standard of care, reflecting the statute's commitment to improving the well-being of Alzheimer's patients and individuals with related neurocognitive disorders. To meet this elevated standard, each patient receives an individualized care plan that is updated per Statute. Additionally, their cognitive function is assessed at least annually. The centers are required to provide therapeutic activities that make up at least 70% of their daily operations. These activities include physical, cognitive, and social exercises, in a spiritually and emotionally supportive environment, designed to engage and support the patients' overall well-being. Key regulatory requirements also include having a licensed nurse on-site for at least 75% of the day, ensuring a one-to-five staff-to-patient ratio, and requiring direct care staff to complete at least 8 hours of dementia-specific training.

#### c. What direct services will be provided to citizens by the appropriation project?

At the Organization's Specialized Day Centers, patients and caregivers are paired with Family Navigators and Case Managers. These professionals help families navigate the often-fragmented healthcare system and create individualized care plans tailored to their unique needs, regardless of language, cultural background, or the stage of disorder. The Family Navigators advocate for essential medical evaluations and interventions to ensure safe medication management, reduce fall risks, prevent complications from preexisting conditions such as diabetes and heart disease, and avoid inappropriate Baker Act placements, among other concerns.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served by ACC includes individuals over the age of 18 with a primary diagnosis of Alzheimer's disease and/or related disorder. Services are available to patients and their caregivers, regardless of culture, race, ethnicity, nationality, religion, financial status, or sexual orientation. With the support of these funds, ACC aims to provide 85,227 hours of patient care, benefiting approximately 285 to 300 families. These services are designed to stabilize the progression of the disease, enabling patients to remain at home with their families and avoid institutionalization for a longer period. Many caregivers, particularly those who are adult children caring for one or both parents while managing their own work responsibilities, raising children, and often supporting college expenses. This highlights the importance of these services in helping caregivers balance their personal and caregiving responsibilities.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Alzheimer's caregivers are deeply committed to preserving the right to care for their loved ones throughout the course of the disease. The Organization's primary goals are to safeguard the well-being, safety, and security of these individuals while maintaining their dignity, integrity, and quality of life throughout the disease progression. Memory care units in long-term care and skilled nursing facilities can cost more than \$12,000 per month, with skilled nursing facilities reaching over \$100,000 per year per resident at Medicaid reimbursement rates. In contrast, the funding of \$1,500,000 for specialized therapeutic day center services for 260 patients offers a significantly more affordable solution. This amount is a fraction of the cost of residential care, which for 285 patients can conservatively exceed \$26 million.

### f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Each of ACC's Specialized Alzheimer Adult Day Centers operate under F.S. 429.918. If these standards are not met, the centers risk losing their licenses issued by the Florida Agency of Health Care Administration. Failure to meet clinical standards could result in the loss of accreditation from the Joint Commission. Additionally, if governance and financial management practices do not comply with required standards, the centers could lose their certification from Non-Profit First, a local organization that annually monitors and evaluates non-profit practices. This could also lead to a loss of funding from four local United Ways and the Palm Beach, Martin, and St. Lucie County Commissioners. Such a loss of funding would further jeopardize financial support from the Palm Beach County/Treasure Coast Area Agency on Aging/ARC and the United Ways of Martin County.
