I. Summary:

The bill provides definitions in the Condominium Act and Cooperative Act for the term "buyer" and provides that it can be interchangeably used with the term "purchaser."

This bill substantially amends the following sections of the Florida Statutes: 718.103, 719.103, and 721.05.

II. Present Situation:

The terms "buyer" and "purchaser" are used interchangeably in chapters 718 and 719, F.S. As defined in Black's Law dictionary, a "buyer" is "one who buys; a purchaser, particularly of chattels." A "purchaser" is defined as "one who acquires real property in any other mode than by descent." Neither term has any additional meaning with regard to the sale of condominiums or cooperatives.

III. Effect of Proposed Changes:

Section 1 defines the term "buyer" as one who purchases a condominium and provides that the term "purchaser" can be used interchangeably.

Section 2 defines the term "buyer" as one who purchases a cooperative and provides that the term "purchaser" can be used interchangeably. This section also reorganizes existing definitions in alphabetical order.

Section 3 modifies a cross-reference to s. 718.103, F.S. in subsection (28) of s. 721.05, F.S., consistent with section 1 of the bill.
