I. SUMMARY:

This memorial urges Congress to enact amendments to the National Voter Registration Act in order to reduce fraudulent voter registration. No state revenues or expenditures are required by this memorial.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

Presently, persons may register to vote without providing proof of identification or verifying the registrant's signature. In fact, current law allows persons to register by mail and vote absentee without ever having been seen by another person. Persons may also register without providing a social security number, which increases the difficulty of monitoring duplication in the voter registration process. Recent voter registration fraud has been linked to these practices.

B. EFFECT OF PROPOSED CHANGES:

The recommended changes would require persons registering to vote to provide appropriate identification. Persons registering by mail would be required to provide either a notarized application photograph or a notarized copy of any authorized form of identification to register to vote. In addition, all newly registered voters would be required to list their Social Security numbers, given that these numbers would remain confidential and exempt from public access.
