I. FINAL ACTION STATUS:

PASSED BY THE LEGISLATURE - CHAPTER 98-179, LAWS OF FLORIDA

House Bill 3205, after passing out of all committees unanimously, was placed on House Consent Calendar. The bill was read second and third times, and on April 16, 1998, passed the House with a vote of 114 Yeas and 0 Nays. On April 17, 1998, the bill was withdrawn from the Governmental Reform and Oversight and Ways and Means committees in the Senate and was substituted on the floor for SB 534. On April 22, 1998, HB 3205 was read a third time and passed the Senate with a vote of 32 Yeas and 0 Nays.

II. SUMMARY:

This bill deletes a date restriction created by Ch. 97-158, Laws of Florida, which limited eligibility for members of the Florida National Guard to receive an exemption of one-half of tuition and fees or, under limited circumstances, to full payment of their tuition and fees, to those members who were enlisted prior to June 30, 1997. This bill allows those Florida National Guard members enlisted after June 30, 1997 to qualify for these benefits, providing an educational safety net in the event that an appropriation providing for a full cost exemption is not made.

The 1998 General Appropriations Act includes \$505,875 to fund this program for fiscal year 1998-1999.

III. SUBSTANTIVE RESEARCH:

A. PRESENT SITUATION:

Under the provisions of section 250.10, Florida Statutes, the Florida National Guard (FNG) operates a tuition-assistance program for degree- or competency-seeking members which provides an exemption of one-half of a member's tuition and fees on a space-available basis, and full payment of tuition and fees for required courses, where admittance cannot be obtained on a space-available basis, and where the individual has been refused admittance on a space-available basis in the past. In 1997, the Legislature adopted Chapter 97-158, Laws of Florida. One of the effect of this bill was to limit this tuition assistance program to those enrolled in the FNG by June 30, 1997. Ch. 97-158, Laws of Florida, also created a new tuition assistance program allowing the Department of Military Affairs, subject to legislative appropriation, to pay the full cost of tuition and fees for all courses taken by new recruits (those who enlist in the National Guard after June 30, 1997).

An eligible FNG member must meet normal admission standards, satisfy age and state residency requirements, maintain satisfactory academic progress, and maintain membership in the Guard for three years following completion of studies for which the exemption was granted. Repayment penalties are assessed for failure to participate in FNG activities, leaving the FNG prior to the three-year term, or ceasing to maintain satisfactory academic progress.

Eligibility is disallowed for FNG members with baccalaureate degrees, with at least fifteen years of service creditable toward retirement, and members who have not completed basic training. All courses for which tuition assistance is applied must lead toward a degree or satisfy vocational-technical training. An upper limit of 1,000 members of the FNG is annually authorized.

Global political factors during the current decade have visited their own effects upon National Guard units in the fifty states. The FNG has had to cope with an increasingly competitive civilian labor market and an active service component which, while smaller, can offer more lucrative incentives for professional commitment and advancement. For the first time, the FNG has fallen short of its force requirements. The states of Hawaii, Louisiana, West Virginia, and Alabama have offered full, rather than partial, educational assistance programs and have managed to achieve their force complements in spite of cutbacks. Essentially such a program acts as a civilian GI Bill for FNG personnel who have a full-time civilian commitment and only a part-time state military service obligation.

There is a concern that the appropriation for the full cost of tuition and fees for all courses may not always be available. Because of the date restriction added by Ch. 97-158, Laws of Florida, members who joined after June 30, 1997 will not be eligible to receive benefits under the older tuition assistance program which provides, at minimum, an exemption from one-half of the member's tuition and fees. Presently, if no appropriation is made to pay for the increased benefit of full payment of tuition and fees, then new recruits are excluded from receiving the smaller educational benefits provided to other members of the guard. The FNG contends that if the appropriation is cut, their ability to recruit new members will be severely affected.

B. EFFECT OF PROPOSED CHANGES:

The date restriction for the benefits provided to members of the guard other than new recruits is removed so that, at a minimum, all members of the guard would receive an exemption for one-half of their tuition and fees. This bill would provide an educational safety net to new recruits in the event that an appropriation is not made to support the full tuition and fee exemption. The provision added by Chapter 97-158, Laws of Florida, for the full payment of tuition and fees for new recruits, subject to legislative appropriation, remains intact.

- E. SECTION-BY-SECTION RESEARCH:
 - Section 1. Amends section 250.10, F.S., by removing the date restriction on eligibility for the tuition assistance program.

2. Recurring Effects:

HB 3205 will require the Department of Military Affairs, subject to an appropriation, to pay for the full cost of tuition and fees for required courses for all members of the FNG who do not possess a baccalaureate degree and have less than 15 years service creditable towards retirement, if that member is unable to obtain admittance to a class on a space-available basis.

HB 3205 would also require community colleges and universities to pick up the remaining costs for all similarly-eligible FNG members taking space-available classes on a one-half tuition/fee exemption.

3. Long Run Effects Other Than Normal Growth:

By removing the enlistment cut-off date, half-cost and full-cost tuition/fee exemptions would be effectively available to any member of the Florida National Guard at anytime, so long as the member meets the general eligibility requirements:

- a. complete basic training
- b. less than 15 years service creditable towards retirement
- c. have not received a baccalaureate degree
- d. older than 17 years of age

4. Total Revenues and Expenditures:

The 1998 General Appropriations Act includes \$505,875 to fund the tuition assistance program (line item 2066). These funds were provided for recruitment of 625 new members for the Florida National Guard, as well as to maintain the FNG members who are already in the program. The cost is based on 76% (475 students) of those FNG members attending community colleges (at \$40/credit hr) and 24% (150 students) attending universities (269 students) full-time (15 credits/yr). This appropriation will continue the assistance for those FNG members in the full-tuition exemption program who could not attend classes on a space-available basis.

The Department of Military Affairs (DMA) anticipates recruiting 625 new participants per year, and that number will increase comparably for each year over a period of five years. (At that time, DMA anticipates a leveling off of the number of participants as the new participants will begin to equal the number of participants graduating/completing the program.) Based on the FNG's future enlistment goals and projected space-available problems, the DMA would need annual increases of \$331,000 for the next 4 years, for a total annualized program cost of \$1.83 million, at current tuition rate, by the year 2002-2003.

However, if the DMA is unable to fully fund the number of eligible FNG members, state community colleges and universities are liable for up to 50% of these program costs through tuition/fee exemptions for Guardsmen attending class on a space available basis.
