I. <u>SUMMARY</u>:

Chapter 633, F.S., concerns fire protection, and designates the head of the Department of Insurance as the State Fire Marshal. This chapter contains licensure requirements for <u>five</u> classifications of fire protection system contractors (categories I, II, III, IV, V - a.k.a. "fire sprinkler contractors"), including requirements for 24 hours of continuing education (C.E.) *annually* for each licensee in the first four classifications, and for 14 hours in the 5th classification. Currently, fire protection contractors must renew their license every year.

This bill makes the following changes:

- 1) It provides that licensees shall be required to renew their license every *two* years, rather than every year.
- 2) It provides that Contractors I, II, and III shall be required to complete 32 hours of C.E. every two years, rather than 24 hours every year.
- 3) It provides that Contractors IV and V shall be required to complete 14 hours of C.E. every two years, rather than every year.
- 4) It changes the renewal fee from \$150 every year to \$250 every two years. This means a reduction in renewal revenues of approximately \$25,000 every two years. However, the department should also experience a similar reduction in costs incurred, due to the fact that they would be processing renewals only once every two years rather than twice every two years.
- 5) It provides that for that initial renewal subsequent to the effective date of this act, the number of C.E. hours required shall be half (16 or 7, depending on the classification) of what will be required in the future.

II. SUBSTANTIVE RESEARCH:

A. PRESENT SITUATION:

Chapter 633, F.S., concerns fire protection, and designates the head of the Department of Insurance as the State Fire Marshal. This chapter contains licensure requirements for *five* classifications of fire protection system (a.k.a. "fire sprinkler") contractors. There are approximately 500 licensed fire protection contractors in Florida.

"<u>Contractor I</u>" means a contractor whose business includes the execution of contracts requiring the ability to lay out, fabricate, install, inspect, alter, repair, and service all types of fire protection systems, excluding preengineered systems.

"<u>Contractor II</u>" means a contractor whose business is limited to the execution of contracts requiring the ability to lay out, fabricate, install, inspect, alter, repair, and service water sprinkler systems, water spray systems, foam-water sprinkler systems, foam-water spray systems, standpipes, combination standpipes and sprinkler risers, all piping that is an integral part of the system beginning at the point where the piping is used exclusively for fire protection, sprinkler tank heaters, air lines, thermal systems used in connection with sprinklers, and tanks and pumps connected thereto, excluding preengineered systems.

"<u>Contractor III</u>" means a contractor whose business is limited to the execution of contracts requiring the ability to lay out, fabricate, install, inspect, alter, repair, and service CO2 systems, foam extinguishing systems, dry chemical systems, and Halon and other chemical systems, excluding preengineered systems.

"<u>Contractor IV</u>" means a contractor whose business is limited to the execution of contracts requiring the ability to lay out, fabricate, install, inspect, alter, repair, and service automatic fire sprinkler systems for detached one-family dwellings, detached two-family dwellings, and mobile homes, excluding preengineered systems and excluding single-family homes in cluster units, such as apartments, condominiums, and assisted living facilities or any building that is connected to other dwellings. *These types of contractors are often also <u>plumbers</u> licensed under chapter 489, F.S.*

<u>"Contractor V"</u> means a contractor whose business is limited to the execution of contracts requiring the ability to lay out, fabricate, install, inspect, alter, repair, and service the underground piping for a fire protection system using water as the extinguishing agent beginning at the point at which the piping is used exclusively for fire protection and ending no more than 1 foot above the finished floor. *These types of contractors are often also underground utility and excavation contractors, licensed under chapter 489, F.S.*

Requirements for renewal of a license include 24 hours of continuing education (C.E.) annually for each licensee in the first four classifications, and 14 hours in classification V. Currently, fire protection contractors must renew their license every year at a cost of \$150. Most licensees at other state agencies (the Department of Business and Professional Regulation and the Department of Health) require renewal every two years rather than every year, basically as a cost-saving strategy.

Often, a certificateholder of a Contractor V license is also licensed as an Underground Utility and Excavation Contractor under chapter 489, F.S. The licensee is required to complete continuing education courses for both licenses that can be applied to or transferred from one license to another. Construction contractors are required to have 14 hours of C.E. before renewing their *biennial* license.

B. EFFECT OF PROPOSED CHANGES:

This bill: (1) Changes the fire protection contractor license from an annual license to a biennial license; (2) Slightly reduces the number of continuing education required of fire protection contractors I, II, and III; (3) Substantially reduces the number of continuing education required of fire protection contractors IV and V; and (5) Provides for reciprocal approval of C.E. courses between certain categories of fire protection contractors and construction contractors licensed pursuant to chapter 489, F.S.

D. STATUTE(S) AFFECTED:

Sections 633.537, 633.524, and 633.60, F.S.

E. SECTION-BY-SECTION RESEARCH:

<u>Section 1.</u> Amends s. 633.524, F.S., to provide that the biennial renewal fee shall be \$250, rather than having an annual renewal fee of \$150.

Section 2. Amends s. 633.537, F.S., to provide that:

- The fire protection contractor license shall expire after two years (rather than one);
- 2) An inactive license expires after two years, rather than three;
- 3) Contractors I, II, and III shall be required to complete 32 hours of C.E. every two years, rather than 24 hours every year.
- 4) Contractors IV and V shall be required to complete 14 hours of C.E. every two years, rather than every year.
- 5) Any C.E. courses approved for plumbers by the Construction Industry Licensing Board (CILB) shall be considered as approved for a Contractor IV;
- Any C.E. courses approved for any of the classifications of a fire protection contractor shall be considered as approved for any licensees under the CILB;
- 7) For that initial renewal (June 30, 1998) subsequent to the effective date of this act, the number of C.E. hours required shall be half of what will be required in the future for a biennial licensure.

<u>Section 3.</u> Amends s. 633.60, F.S., to make a technical change to reflect moving from annual to biennial renewal.

<u>Section 4.</u> Provides that the act shall take effect upon becoming a law.

III. FISCAL RESEARCH & ECONOMIC IMPACT STATEMENT:

There are approximately 500 licensed fire protection contractors in Florida. The department will lose approximately \$25,000 by going to a biennial renewal. However, it would appear that the department can expect to save a similar amount by having to perform only one renewal cycle every two years, rather than two during that same period.

IV. CONSEQUENCES OF ARTICLE VII, SECTION 18 OF THE FLORIDA CONSTITUTION:

A. APPLICABILITY OF THE MANDATES PROVISION:

This bill does not require counties or municipalities to spend funds or to take an action requiring the expenditure of funds.

B. REDUCTION OF REVENUE RAISING AUTHORITY:

This bill does not reduce the authority that municipalities or counties have to raise revenues in the aggregate.

C. REDUCTION OF STATE TAX SHARED WITH COUNTIES AND MUNICIPALITIES:

VI. AMENDMENTS OR COMMITTEE SUBSTITUTE CHANGES:

The amendments adopted in the Business Regulation and Consumer Affairs Committee made several changes, including: (1) Moving the proposed biennial licensure fee from \$225 to \$250; (2) Changing the C.E. hours biennially required of Contractors I, II, and III from 24 to 32 hours; (3) Providing that Contractors IVs are only required to complete 14 C.E. hours biennially (similarly to existing law for Contractor Vs); (4) Establishing that any C.E. courses approved by the CILB for plumbers shall also be considered as approved for Contractor IVs; and (5) Establishing that any C.E. courses approved by the Fire Marshal for any classification of fire protection contractor shall be considered approved for any of the licensees under the CILB.
