I. SUMMARY:

The bill creates s. 810.14, F.S., which prohibits a person from entering upon real property for the lewd purpose of secretly observing a person inside a building through a window.

The effective date is October 1, 1998.

II. SUBSTANTIVE RESEARCH:

A. PRESENT SITUATION:

Trespass

Current law prohibits the entry upon private lands. Section 810.09, F.S. (trespass), is defined as follows:

A person who, without being authorized, licensed, or invited, willfully enters upon or remains in any property other than a structure or conveyance:

- 1. As to which notice against entering or remaining is given, either by actual communication to the offender or by posting, fencing, or cultivation as described in s. 810.011; or
- 2. If the property is the unenclosed curtilage of a dwelling and the offender enters or remains with the intent to commit an offense thereon, other than the offense of trespass,

commits the offense of trespass on property other than a structure or conveyance.

Definitions

A "conveyance" is any motor vehicle, ship, vessel, etc.

<u>A "structure"</u> is a building of any kind, either temporary or permanent, which has a roof over it, together with the curtilage thereof.

The "curtilage" is any land or building immediately adjacent to a dwelling.

Laws prohibiting Voyeurism

The Florida Statutes contain no law which prohibits conduct amounting to a "peeping Tom." Other states have such laws (e.g., Georgia, Missouri). Still, others have laws which prohibit the secret videotape, photograph or filming of persons in private accommodations (e.g., Michigan, Virginia, Georgia, Missouri).

B. EFFECT OF PROPOSED CHANGES:

A "Peeping Tom" Law

The one-paragraph bill is as follows:

810.14 Voyeurism prohibited.--A person may not, without being authorized, licensed, or invited, enter onto real property for the lewd, lascivious, or indecent purpose of secretly observing the occupant of a building or structure through a window or other opening. A person who violates this section commits a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084.

<u>A lewd, lascivious, or indecent purpose</u> is defined by Florida Standard Jury Instructions as meaning a wicked, lustful, unchaste, licentious, or sensual intent on the part of the person doing the act.

Thus, the bill punishes a "peeping Tom" who secretly peers through windows of other people's homes (or other buildings) for sexual gratification.

Effective Date

The effective date is October 1, 1998.

Because the bill involves a criminal law, it is exempt from the mandate.

V. <u>COMMENTS</u>:

New Law Requires Trespass

Because the bill is tied to trespass, it does not cover other conduct whereby a person secretly observes others in situations in which they have a reasonable expectation of privacy. For example, it does not cover the voyeuristic neighbor who secretly observes from his own property, nor the telescopic voyeur who escapes punishment from the same act because he is at a distance. Moreover, peering into a window from any location would not be a violation of the law unless lewd and lascivious intent can be demonstrated. Nor does

the bill cover dressing rooms, public-bathroom stalls, tanning booths, or any other private accommodation.

Finally, the bill is not limited to dwellings (homes), but includes any building or structure (private businesses, public offices, etc.).

Previously Attempted Legislation

In 1974, the House passed a bill (HB 3864) which contained the following provision:

Any person found looking into the residence of another person without that person's consent, for voyeuristic purposes shall be guilty of a misdemeanor of the second degree punishable as provided in Sections 775.082 or 775.083.

	However, the bill died in the Senate.
