#### I. FINAL ACTION STATUS:

HB 4599 passed the House on April 23, 1998; in the Senate was substituted for SB 2508 and passed on May 1, 1998. Became law without Governor's signature on May 30, 1998. Chapter Law 98-356.

#### II. SUMMARY:

This legislation re-creates the Indigent Criminal Defense Trust Fund without modification. The Indigent Criminal Defense Trust Fund is administered by the Justice Administration Commission.

### III. SUBSTANTIVE RESEARCH:

#### A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 27.52, F.S. creates the trust fund

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The Indigent Criminal Defense Trust Fund will be administered by the Justice Administration Commission, and appropriated proportionally to the amounts collected by each circuit court. The Legislature for fiscal year 1998-1999 hereby appropriates \$268,758.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

Provides for a revenue source from \$40 fees collected in conjunction with determinations of indigency.
