This resolution would authorize the President of the Senate and the Speaker of the House to form an interim task force study in order to review and clarify the current provisions of Florida's ethics laws. The six-member task force would consist of a member of the Senate as the chair and two other members from the Senate appointed by the Senate President, and a member of the House as the vice-chair and two other members of the House appointed by the Speaker, with at least one member from the minority party in each chamber. The task force would make recommendations to improve Florida's ethics laws. State and local government associations, in addition to the public, would be invited to contribute to the task force study.

The task force would be assisted and supported by the staff of the Florida Senate and the Florida House of Representatives.

II. SUBSTANTIVE RESEARCH:

The current provisions of Florida's ethics laws contain ambiguities and inconsistencies in their application to elected officials and government personnel. Current laws are often unclear on the issue of jurisdiction over alleged ethics violations.
