Paragraphs (a) and (b) of subsection (1) of 11 12 section 458.317, Florida Statutes, are amended to read: 458.317 Limited licenses.--13 14 (1)(a) Any person desiring to obtain a limited license 15 shall: 16 Submit to the board, with an application and fee 17 not to exceed \$300, an affidavit stating that he has been 18 licensed to practice medicine in any jurisdiction in the 19 United States for at least 10 years and has retired or intends to retire from the practice of medicine and intends to 20 practice only pursuant to the restrictions of a limited 21 22 license granted pursuant to this section. However, if a 23 physician is not fully retired in all jurisdictions, he can only use the limited license for non-compensated practice. If 24 the person applying for a limited license submits a notarized 25 26 statement from the employing agency or institution stating 27 that he will not receive monetary compensation for any service involving the practice of medicine, the application fee and 28 29 all licensure fees shall be waived. 30 Meet the requirements in s. 458.311(1)(b)-(f) and If the applicant graduated from medical school prior to

1946, the board or its appropriate committee may accept military medical training or medical experience as a substitute for the approved 1-year residency requirement in s. 458.311(1)(f).

(b) After approval of an application under this section, no license shall be issued until the applicant provides to the board an affidavit that the applicant has in fact retired from the practice of medicine in this or any other jurisdiction in which the applicant holds a license and that there have been no substantial changes in status since initial application.

Nothing herein limits in any way any policy by the board, otherwise authorized by law, to grant licenses to physicians duly licensed in other states under conditions less restrictive than the requirements of this section.

Notwithstanding the other provisions of this section, the board may refuse to authorize a physician otherwise qualified to practice in the employ of any agency or institution otherwise qualified if the agency or institution has caused or permitted violations of the provisions of this chapter which it knew or should have known were occurring.
