I. Summary:

The bill restores eligibility provisions for partial tuition assistance authorized for members of the Florida National Guard which was deleted erroneously by Chapter 97-158, Laws of Florida.

This bill substantially amends section 250.10, Florida Statutes.

II. Present Situation:

The Florida National Guard has administered a partial (50 percent) tuition assistance program as an incentive to recruitment and retention in the uniformed service. The program is directed principally at eligible high-school graduates who see a compatibility between part-time, military service and a full-time, civilian job. In an effort to encourage its recruitment efforts, relative to other state guard units and the realignment and worldwide reduction of United States military forces, the Florida National Guard recommended, and the Legislature passed, an increase in this assistance level to 100 percent of tuition, prospectively to new enlistments. The force realignment will place a premium on state guard units meeting their recruitment and retention quotas in order to retain their current and future force complements. More than one-half of Florida Army Reserve National Guard units are combat units with the remainder in logistics, supply, and transportation specialties. Future unit acquisitions will experience a growth in more technical skill areas in RADAR and missile technology.

A consequence of this increase was the simultaneous repeal of the 50 percent assistance level, the effect of which would eliminate any such program should a 100 percent funding level not be provided by a subsequent Legislature in its annual appropriations act.
