I. FINAL ACTION STATUS:

CS/SB 752 passed the Senate (38/0) and House (114/0). On May 21, 1998 CS/SB 752 was approved by the Governor (Ch. 98-398).

II. SUMMARY:

This bill designates the following: the tennis court complex at the University of West Florida as "The Harold 'Skeeter' Carson Tennis Complex"; the Lifelong Learning Center at Florida Atlantic University as "Barry and Florence Friedberg Lifelong Learning Center"; the swim/dive office and training facility at the University of Florida as the "Wayne and Jimmie Carse Swimming and Diving Complex"; Flint Hall at the University of Florida as the "Keene-Flint Hall"; the residence hall known as 2nd Court, Pei Residence Halls, located on the Sarasota/Manatee Campus of the New College of the University of South Florida as the "Peggy Bates Residence Hall"; the library tower located on the campus of Florida International University as the "Steven and Dorothea Green Library"; the recording facility donated to Florida State University by Echelon International Development Corporation, as "Critchfield Hall"; the Florida Resident Access Grant Program as the "William L. Boyd, IV, Florida Resident Access Grant Program"; the Children's Medical Services Clinic of St. Lucie County as the "Dr. William R. Dannahower Building"; and the Regional Office of the Florida Game and Fresh Water Fish Commission located in West Palm Beach as the "Woodrow 'Woody' Darden Building".

#### III. SUBSTANTIVE RESEARCH:

A. PRESENT SITUATION:

Section 267.062, F.S., provides that no state building, complex, or facility may be named after a living person, except as specifically provided by law.

#### B. EFFECT OF PROPOSED CHANGES:

The tennis court complex at the University of West Florida is designated as "The Harold 'Skeeter' Carson Tennis Complex".

The Lifelong Learning Center at Florida Atlantic University is designated as the "Barry and Florence Friedberg Lifelong Learning Center".

The swim/dive office and training facility at the University of Florida is designated as the "Wayne and Jimmie Carse Swimming and Diving Complex".

Flint Hall at the University of Florida is renamed the "Keene-Flint Hall".

The residence hall known as 2nd Court, Pei Residence Halls, located on the Sarasota/Manatee Campus of New College of the University of South Florida is designated as the "Peggy Bates Residence Hall".

The library tower located on the campus of Florida International University is designated as the "Steven and Dorothea Green Library".

The recording facility donated to Florida State University by Echelon International Development Corporation, is designated as "Critchfield Hall";

The Florida Resident Access Grant Program is designated as the "William L. Boyd, IV, Florida Resident Access Grant Program";

The Children's Medical Services Clinic of St. Lucie County is designated as the "Dr. William R. Dannahower Building";

The Regional Office of the Florida Game and Fresh Water Fish Commission located in West Palm Beach is designated as the "Woodrow 'Woody' Darden Building".

E. SECTION-BY-SECTION RESEARCH:

**Section 1**. Coach "Skeeter" Carson has had a long and exemplary career as the University of West Florida's first tennis coach. Coach Carson's philosophy of making sure students are winners in life is a hallmark that surpasses even his notable athletic accomplishments.

Coach Carson has won numerous awards during his tenure including two United States Tennis Association Collegiate Outstanding Service Awards, the Coach of the Year award on ten different occasions by the NAIA, and the NCAA Gulf South Conference Coach of the Year in 1995, 1996, and 1997. Coach Carson received special recognition in the May, 1991 issue of <u>Tennis Magazine</u>. The article stressed Coach Carson's philosophy of making sure kids are winners in life as well as in tennis. Recognition was also received when Coach Carson was inducted into the Pensacola Sports Hall of Fame.

During Coach Carson's tenure, his players have received 4 Arthur Ashe Awards for Sportsmanship, 3 Graduate Awards, 2 Senior Players of the Year, 1 Outstanding Player of the Year, and 1 Freshman Player of the Year, with 117 All-American Awards. Ten of his players have won national championships.

In addition to his college coaching duties, Coach Carson has been very involved with the Greater Pensacola Tennis Association and the USTA. He served on the GPTA Board of Directors for 8 years, was a GPTA Tournament Director for 5 years, and was the GPTA President for 2 years. He has been a volunteer for numerous charity, USTA, and junior tennis events, assisting in fundraising and player development.

Coach Carson led the drive to place additional courts and a clubhouse at the UWF tennis facility which resulted in a special recognition of the tennis complex by the USTA as the Outstanding Collegiate Tennis Facility in 1991.

CS/SB 752 designates the University of West Florida's tennis court complex as "The Harold 'Skeeter' Carson Tennis Complex" in recognition of his untiring contributions to the community and to his profession.

**Section 2**. Barry and Florence Friedberg have been members of the Lifelong Learning Society since 1985. They have been active in many community based charities and have made a significant contribution to the construction fund of the Lifelong Learning Center.

Florida Atlantic University's Lifelong Learning program is one of the most successful in the United States, with about 14,500 members in or near their retirement years. The Lifelong Learning Center is believed to be the only building ever to be constructed at an American University to serve the needs of students of retirement age.

CS/SB 752 designates the Lifelong Learning Center on the Boca Raton Campus, the first Lifelong Learning Center to be constructed on any of the seven campuses of Florida Atlantic University for use by the Lifelong Learning Society, as the "Barry and Florence Friedberg Lifelong Learning Center" in honor of the Center's major benefactors.

**Section 3**. Wayne and Jimmie Carse are loyal and distinguished friends of the University of Florida. They have pledged \$800,000 for the construction of the new swimming and diving office and training facility.

CS/SB 752 designates the swim/dive office and training facility at the University of Florida as the "Wayne and Jimmie Carse Swimming and Diving Complex" in recognition of their contributions to the university, its students, and to the residents of the State of Florida.

**Section 4**. Kenneth K. Keene, a distinguished alumnus of the University of Florida, has contributed \$3,000,000 for the renovation of the historic Flint Hall at the University of Florida.

CS/SB 752 renames Flint Hall at the University of Florida, the "Keene-Flint Hall" in recognition of his contributions to the university, its students, and to the residents of the State of Florida.

**Section 5**. Dr. Margaret Bates served as Chair of the Division of Social Sciences at New College at the University of South Florida from 1971 to 1975 and was Professor of Political Science at New College of USF from 1975 until her retirement in 1995. Dr. Bates also served with distinction as Interim Provost, New College of USF, from 1989 to 1992.

Dr. Bates generously volunteered her wisdom and talent in support of Sarasota community activities bringing great recognition and credit to New College of the University of South Florida, the University of South Florida, and the State University System.

Dr. Bates donated over \$90,000 to the New College Foundation for the Gateway Scholars Endowment. An anonymous Foundation trustee, so impressed by her generosity, subsequently contributed \$60,000 increasing the gift to \$150,000.

CS/SB 752 designates the residence currently known as 2nd Court, Pei Residence Halls located on the Sarasota/Manatee Campus of the University of South Florida/New College as the "Peggy Bates Residence Hall" in recognition of Dr. Margaret Bates' tireless and dedicated services to New College and the Sarasota/Manatee community.

**Section 6**. Mr. Steven Green, a prominent international business leader, was recently appointed to be our nation's ambassador to Singapore. Ambassador Green is founder and managing partner of Greenstreet Partners, a private merchant bank based in Miami.

Ambassador Green's philanthropic contributions have been widespread. He served on the board of the Children's Health Fund, the President's Export Council, and the University of Miami Advisory Board. He was a trustee of United Way and a member of the FIU Foundation Board of Trustees.

Ambassador Green and Mrs. Dorothea Green recently committed \$2.5 million, which will be matched in state funds, to establish endowments for the library and the museum at Florida International University.

CS/SB 752 designates the library tower located on the campus of Florida International University as the "Steven and Dorothea Green Library" in recognition of their support to the arts and library programs at Florida International University. The library is scheduled to be completed in the latter part of 1998.

**Section 7**. Dr. Jack Critchfield, an outstanding business leader, has taken Florida Progress Corporation to the height of the public utilities field in Florida. He currently serves as Chairman of Florida Progress Corporation and prior to that was Chairman, Chief Executive Officer and Vice President for more than ten years.

He serves as Co-Chairman of the Florida Commission on Education, is a former Chairman of the Education Committee of the Governor's Commission for Government by the People, and is a member of the national Business-Higher Education Forum. Echelon International Development Corporation recently donated a recording facility to Florida State University's Investment in Learning Campaign. This facility will provide the School of Motion Pictures, Television and the Recording Arts with a recording arts facility.

CS/SB 752 officially designates the recording studio facility as "Critchfield Hall" in recognition of Dr. Critchfield's generosity and philanthropic contributions not only to the university but to the State of Florida.

**Section 8.** Authorizes the universities to erect suitable markers.

**Section 9**. CS/SB 752 designates the Florida Resident Access Grant Program to be renamed the William L. Boyd, IV, Florida Resident Access Grant Program.

**Section 10.** CS/SB 752 designates the Children's Medical Services Clinic of St. Lucie to be renamed "The Dr. William R. Dannahower Building".

**Section 11.** CS/SB 752 designates the Regional Office of the Fresh Water Fish Commission in West Palm Beach as "The Woodrow 'Woody' Darden Building".

Section 12. Provides an effective date.
