II. SUBSTANTIVE RESEARCH:

A. PRESENT SITUATION:

Currently there is no specific statutory authority for water management districts to accept donations, grants, funds, or services from private donors. Chapter 94-279, Laws of Florida, provides specific authority for the St. Johns River Water Management District to accept private donations for the limited purpose of the restoration of Lake Jessup, in Seminole County. Additionally, there are specific instances where statutory authority is provided for certain state agencies to accept gifts from private donors for certain purposes. One instance is s. 369.20, F.S., which specifies that the Department of Environmental Protection can receive private donations for aquatic plant control.

The St. Johns River Water Management District is particularly interested in obtaining the authority to accept donations from private sources because a number of private organizations have expressed interest in donating funds for the Indian River Lagoon Surface Water Improvement and Management (SWIM) program.
