I. FINAL ACTION STATUS:

HB 1327 passed the House on March 9, 1999, and passed the Senate on March 16, 1999. The bill was approved by the Governor and became law April 6, 1999 (Chapter 99-96, Laws of Florida).

II. SUMMARY:

This legislation re-creates the Air Pollution Control Trust Fund without modification, effective November 4, 2000. The Air Pollution Control Trust Fund, FLAIR #37-2-035, is administered by the Department of Environmental Protection. This fund was last re-created effective November 4, 1996, by Chapter 95-31, Laws of Florida.

III. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Sections 320.03, 376.60, 403.0873, and 403.518, F.S., provide revenue sources for the trust fund.

BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The trust fund was established for funding of mobile surface air pollution monitoring and control programs; odor and toxic air pollutant identification; monitoring and control activities; and other stationary source program activities.

MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are asbestos and air emission operating fees, tag fees, and federal grant funds. According to Comptroller data, receipts to this fund for FY 1997-98 were \$45.4 million.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.

C. STATUTE(S) AFFECTED:

None.
