I. FINAL ACTION STATUS:

HB 1329 passed the House on March 9, 1999, and passed the Senate on March 16, 1999. The bill was approved by the Governor and became law April 6, 1999 (Chapter 99-97, Laws of Florida).

II. SUMMARY:

This legislation re-creates the Administrative Trust Fund without modification, effective November 4, 2000. The Administrative Trust Fund, FLAIR #37-2-021, is administered by the Department of Environmental Protection. This fund was last re-created effective November 4, 1996, by Chapter 95-30, Laws of Florida.

III. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

MAJOR STATUTES THAT CONTROL THE TRUST FUND:

This trust fund was re-created in Chapter 95-30, L.O.F. and is not contained in the Florida Statutes.

BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The trust fund supports the operation of the Division of Administration and the Executive Office of the Department of Environmental Protection.

MAJOR SOURCES OF REVENUE FOR THE FUND:

The major source of revenue for the fund is an administrative fee assessment against other trusts funds within the Department of Environmental Protection. According to Comptroller data, receipts to this fund for FY 1997-98 were \$22.9 million.

EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
