I. Summary:

This bill authorizes the Division of Alcoholic Beverages and Tobacco to issue a special alcoholic beverage license to the Board of Directors of the Dunedin Fine Art Center, Inc. for special events only. The Board of Directors could transfer the license to authorized food service providers. The package sale of alcoholic beverages is prohibited.

This bill takes effect upon becoming law.

II. Present Situation:

In order to sell alcoholic beverages in Florida, entities must be licensed by the Division of Alcoholic Beverages and Tobacco. There are three ways to become licensed.

1. Quota licenses

Section 561.20, F.S., provides for issuance of "quota licenses" so that the number of such licenses within a county not exceed one per 5,000 residents. The law provides for an annual lottery-type drawing to award quota licenses based on population growth.

2. Special licenses

Section 561.20, F.S., carves out several exceptions to the quota provision and expressly authorizes special licensure for certain facilities, including restaurants, hotels, bowling establishments and airports.

3. Special acts

Facilities not expressly exempted from the quota provision may seek special licensure through the legislative process.

The Board of Directors of the Dunedin Fine Art Center, Inc., is pursuing a special license through the legislative process.

III. Effect of Proposed Changes:

This bill authorizes the issuance of a special license to the Board of Directors of the Dunedin Fine Art Center for special events only.

This bill allows the Board of Directors to transfer the license to a qualified applicant that is either authorized by or under contract to provide food services at the Center. The license is not valid for use at any other location, and it automatically reverts to the Board of Directors upon termination of the transferee's authority or contract.

The license would not permit the Dunedin Fine Art Center, Inc. or its transferees to sell alcoholic beverages in sealed containers for consumption off the premises.
