(b) A list of the acts to be performed. 1 2 (c) A statement disclosing that the male has received 3 training in the responsibilities of fatherhood within the past 4 3 months. 5 (d) A statement of any sexually transmitted disease 6 with which either party is infected. 7 (e) If a condom is not to be used, a statement that both parties consent to the act of intercourse without the 8 9 condom. 10 (f) Consent to any medical testing required to determine the paternity of a child resulting from the act. 11 12 (g) A statement by both parties that if pregnancy 13 results from the act of intercourse, both will be responsible for the support of a child resulting from the act of 14 15 intercourse, in amounts to be determined by the Child Support Guidelines of s. 61.30(6), Florida Statutes, or the order of a 16 17 circuit court. 18 (h) A statement that consent for the act of intercourse may be withdrawn verbally at any time, and that 19 20 continuation of sexual activity on the part of either party is 21 sexual battery and subjected to the provisions of chapter 794, 22 Florida Statutes.
