I. <u>SUMMARY</u>:

This bill renames the current Tobacco Settlement Trust Fund to the Department of Health Tobacco Settlement Trust Fund. The need for this change results from the need to accurately account for funds recieved by the state from the settlement of a lawsuit by the State of Florida against tobacco manufacturers and other defendants.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

The State of Florida commenced a legal action against various tobacco manufacturers and other defendants in February, 1995, asserting various claims for monetary and injunctive relief on behalf of the State of Florida.

On August 25, 1997, the State of Florida entered into a settlement agreement with several of the tobacco companies. The companies agreed to make annual payments to the state and in order to accurately account for these settlement funds the Tobacco Settlement Trust Fund was created effective May 22, 1998, by Chapter 98-122, Laws of Florida.

B. EFFECT OF PROPOSED CHANGES:

The Department of Banking and Finance Tobacco Settlement Clearing Trust Fund is being created in another bill. That trust fund will be credited with all the annual payments received by the state from the settlement. These funds will be disbursed by a nonoperating transfer from the clearing trust fund to the tobacco settlement trust funds of the various agencies in amounts equal to the annual appropriations made from those trust funds in the General Appropriations Act. Additionally the Department of Banking and Finance will disburse funds, by nonoperating transfer, from the clearing trust fund to the Lawton Chiles Endowment Fund for Children and Elders (also being created in another bill) in amounts specified by law. Any unencumbered balance in the various agency tobacco settlement trust funds at the end of any fiscal year and any encumbered balance remaining undisbursed on December 31 of the same calendar year shall revert to the Lawton Chiles Endowment Fund for Children and Elders.

The Lawton

Chiles Endowment Fund for Children and Elders, is to be created within the State Board of Administration and will serve as a clearing trust fund. Funds from the endowment will be distributed to the Department of Health, the Department of Children and Family Services, the Department of Elderly Affairs, and the Agency for Health Care Administration, in the amounts indicated in the legislative appropriations for state agencies. The state agencies will use these funds to enhance and support increases in clients served or in program costs in the following program areas: children's health care, child welfare, and community-based service initiatives for the elderly.

This bill renames the current

Tobacco Settlement Trust Fund to the Department of Health Tobacco Settlement Trust Fund to account for the spending of those tobacco settlement funds that are authorized by law to be expended by the department. Further this bill moves current statutory language creating the fund from Chapter 562, related to the Department of Business and Professional Regulation dealing with alcohol and tobacco regulation, to an appropriate chapter relating to Department of Health trust funds.
