### I. Summary:

The bill provides a \$2 million appropriation from non-recurring tobacco settlement trust funds to the Department of Health to reimburse rural counties with a population of less than 75,000 for expenditures associated with treating indigent patients suffering from tobacco-related illnesses.

### II. Present Situation:

Currently, section 409.915, F.S., requires counties to contribute 35 percent of the cost for Medicaid inpatient hospital days beginning with days 13 through day 45, with the exception of pregnant women and children whose income is in excess of the federal poverty level and who do not participate in the Medicaid medically needy program.

## **III.** Effect of Proposed Changes:

Section 1 provides a \$2 million appropriation from non-recurring tobacco settlement trust funds to the Department of Health to reimburse rural counties for expenditures associated with treating indigent patients suffering from tobacco-related illnesses.

Section 2 directs the Department of Health to disburse funds appropriated to the following counties:
