I. SUMMARY:

The bill's provisions resulted from the State Government Function/Activity Review Interim Project. As part of the Project, statutory provisions relating to the Department of Highway Safety and Motor Vehicles (DHS&MV) were reviewed to determine their consistency with the agency's mission.

Vessel registration and safety are administered by both the Department of Environmental Protection (DEP) and DHS&MV. DEP is responsible for vessel safety and DHS&MV is responsible for vessel registration.

The bill transfers vessel registration statutes from chapter 327 to chapter 328, F.S. (vessel titles). This would place DHS&MV's vessel registration and titling responsibilities into the same chapter of the Florida Statutes.

Chapter 327, F.S., would continue to be related to vessel safety and be administered by DEP.

Reorganizing the statutes will serve to align the statutes according to the missions and responsibilities of DEP and DHS&MV.

Because the proposed changes are technical in nature, the bill has no substantive or fiscal impact.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

On November 17, 1997, the Speaker of the Florida House of Representatives directed House committees to perform several activities relating to the State Agency Function/Activity Review and Prioritization Project. Statutory provisions relating to the DHS&MV's operations were reviewed to determine their consistency with the agency's mission. As part of the Project, staff was instructed to identify statutes that are obsolete or in need of technical revision.

Chapter 327, F.S., is administered by DEP and DHS&MV. DHS&MV is responsible for vessel registration and DEP is responsible for vessel safety.

Chapter 328, F.S., relates to vessel titles and is administered by DHS&MV.

In January 1998, the Committee on Transportation issued a report in response to the Speaker's directive. PCB TR 99-03 (HB 589) was prepared as part of the Project and is intended to place DHS&MV's vessel registration and titling responsibilities into the same chapter of law.

B. EFFECT OF PROPOSED CHANGES:

The bill transfers vessel registration statutes from chapter 327 to chapter 328, F.S. This would place DHS&MV's vessel registration and titling responsibilities into the same chapter of the Florida Statutes. Chapter 327, F.S., would continue to be related to vessel safety and be administered by DEP.

Reorganizing the statutes will serve to align the statutes according to the missions and responsibilities of the DEP and DHS&MV.
