All members of the panel shall be appointed by October 1, 1999, and the panel shall hold its organizational meeting no later than December 10, 1999. a. A consumer advocate for senior citizens appointed by the Governor, to serve a 4-year term. b. Two persons with expertise in the fields of quality management, service delivery excellence, or public-sector accountability appointed by the Governor, to serve 3-year terms. c. A consumer advocate for senior citizens appointed by the Secretary of Elderly Affairs, to serve a 4-year term. d. An active member of a nursing <u>facility family and</u> resident care council appointed by the Secretary of Elderly Affairs, to serve a 1-year term. e.
