soon as practicable, and the Comptroller shall close out and remove the terminated fund from the various state accounting systems using generally accepted accounting principles concerning warrants outstanding, assets, and liabilities. Section 2. The Child Care and Development Block Grant Trust Fund within the Department of Children and Family Services, FLAIR number 60-2-098, is renamed the Child Care Development Trust Fund. Section 3. This act shall take effect July 1, 2000. HOUSE SUMMARY Terminates specified trust funds administered by the Agency for Health Care Administration, the Department of Children and Family Services, or the Department of Veterans' Affairs. Provides for disposition of balances in and revenues of such trust funds and prescribes procedures for their termination. Renames a trust fund within the Department of Children and Family Services.
