Section 1. This act may be cited as the "Justin Marks
z Teen Safety Driving Act."

Section 2. Subsections (4) and (5) of section 316.614,
Florida Statutes, are amended to read:

316.614 Safety belt usage.--

(4) It is unlawful for any person:

(a) To operate a motor vehicle in this state unless
each passenger of the vehicle under the age of 18 ~~16~~ years is
restrained by a safety belt or by a child restraint device
pursuant to s. 316.613, if applicable; or

(b) To operate a motor vehicle in this state unless
the person is restrained by a safety belt.

(5) It is unlawful for any person 18 ~~16~~ years of age
or older to be a passenger in the front seat of a motor
vehicle unless such person is restrained by a safety belt when

1 the vehicle is in motion.

2 Section 3. Section 322.05, Florida Statutes, is
3 amended to read:

4 322.05 Persons not to be licensed.--The department may
5 not issue a license:

6 (1) To a person who is under the age of 16 years,
7 except that the department may issue a learner's driver's
8 license to a person who is at least 15 years of age and who
9 meets the requirements of ss. 322.091 and 322.1615 and of any
10 other applicable law or rule.

11 (2) To a person who is at least 16 years of age but is
12 under 18 years of age unless the person meets the requirements
13 of s. 322.091 and holds a valid:

14 (a) Learner's driver's license for at least 12 6
15 months, with no traffic convictions, before applying for a
16 license; ~~or~~

17 (b) Learner's driver's license for at least 12 months
18 and who has a traffic conviction but elects to attend a
19 traffic driving school for which adjudication must be withheld
20 pursuant to s. 318.14; or

21 (c)~~(b)~~ License that was issued in another state or in
22 a foreign jurisdiction and that would not be subject to
23 suspension or revocation under the laws of this state.

24 (3) To a person who is at least 16 years of age but
25 who is under 18 years of age unless the parent, guardian, or
26 other responsible adult meeting the requirements of s. 322.09
27 certifies that he or she, or another licensed driver 21 years
28 of age or older, has accompanied the applicant for a total of
29 not less than 50 hours behind-the-wheel experience, of which
30 not less than 10 hours shall be at night This subsection is
31 not intended to create a private cause of action as a result

1 of the certification. The certification is inadmissible for
2 any purpose in any civil proceeding.

3 (4)~~(3)~~ Except as provided by this subsection, to any
4 person, as a Class A licensee, Class B licensee, Class C
5 licensee, or Class D licensee, who is under the age of 18
6 years. A person age 16 or 17 years who applies for a Class D
7 driver's license is subject to all the requirements and
8 provisions of ss. 322.09 and 322.16(2) and (3). Any person
9 who applies for a Class D driver's license who is age 16 or 17
10 years must have had a learner's driver's license or a driver's
11 license for at least 90 days before he or she is eligible to
12 receive a Class D driver's license. The department may require
13 of any such applicant for a Class D driver's license such
14 examination of the qualifications of the applicant as the
15 department considers proper, and the department may limit the
16 use of any license granted as it considers proper.

17 (5)~~(4)~~ To any person whose license has been suspended,
18 during such suspension, nor to any person whose license has
19 been revoked, until the expiration of the period of revocation
20 imposed under the provisions of this chapter.

21 (6)~~(5)~~ To any person, as a commercial motor vehicle
22 operator, whose privilege to operate a commercial motor
23 vehicle has been disqualified, until the expiration of the
24 period of disqualification.

25 (7)~~(6)~~ To any person who is an habitual drunkard, or
26 is an habitual user of narcotic drugs, or is an habitual user
27 of any other drug to a degree which renders him or her
28 incapable of safely driving a motor vehicle.

29 (8)~~(7)~~ To any person who has been adjudged to be
30 afflicted with or suffering from any mental disability or
31 disease and who has not at the time of application been

2 (9)~~(8)~~ To any person who is required by this chapter
3 to take an examination, unless such person shall have
4 successfully passed such examination.

5 (10)~~(9)~~ To any person, when the department has good
6 cause to believe that the operation of a motor vehicle on the
7 highways by such person would be detrimental to public safety
8 or welfare. Deafness alone shall not prevent the person
9 afflicted from being issued a Class D or Class E driver's
10 license.

11 (11)~~(10)~~ To any person who is ineligible under s.
12 322.056.

13 Section 4. Notwithstanding sections 322.05(2) and (3),
14 Florida Statutes, a person who is at least 16 years of age but
15 who is under 18 years of age who meets the requirements of
16 section 322.091, Florida Statutes, and has held a valid
17 learner's driver's license for at least 6 months prior to
18 October 1, 2000, may be issued a driver's license by the
19 Division of Driver Licenses of the Department of Highway
20 Safety and Motor Vehicles.

21 Section 5. This act shall take effect October 1, 2000.
