## I. Amendments Contained in Message

House Amendment 1 delays the effective date of sections 27, 28, 29 of the bill.
House Amendment 2 delays the effective date of sections 6 and 7 of the bill.
House Amendment 3 delays the effective date of sections 4 and 5 of the bill.
House Amendment 4 (body with title) strikes an exemption to public records requirements.
House Amendment 5 removes statute transferring funds from the Corporations Trust Fund.
House Amendment 6 (body with title) creates requirements for a direct-support organization.
House Amendment 9 clarifies funding for Coconut Grove Playhouse.
House Amendment 10 adds SB 392 to the bill.

## II. Summary of Amendments Contained in Message

**House Amendment 1** delays by one year the effective date of sections 27, 28 and 29 of the bill. Sections 27 and 28 make cross-reference changes to ss. 849.085 and 849.0931, F.S., effective on July 1, 2001, instead of July 1, 2000. Additionally, the amendment delays the transfer of game promotions regulation to the Department of Agriculture and Consumer Services until July 1, 2001, instead of July 1, 2000.

**House Amendment 2** delays by one year effective date of sections requiring reports to be filed directly with the Commission on Ethics, instead of the Department of State. Gives the commission the time to prepare.

**House Amendment 3** delays by six months effective date of sections requiring reports to be filed directly with the Commission on Ethics, instead of the Department of State. Gives the commission the time to prepare.

**House Amendment 4** (body with title) strikes a provision making exempt from public records requirements proprietary business information and trade secrets received by the Department of Agriculture in sales of liquid fuels investigations.

**House Amendment 5** removes language from bill providing for transfer each year from the Corporations Trust Fund \$10 million to Cultural Institutions Trust Fund; \$13 million to the Historical Resources Operating Trust Fund; and \$10 million to the Library Services Trust Fund. **House Amendment 6** (body with title) creates requirements for direct-support organization for Department of Military Affairs.

**House Amendment 9** transfers the Ringling Museum to FSU caused a funding question/problem for the Coconut Grove Playhouse. This amendment resolves the problem.

**House Amendment 10** adds CS/SB 392, which passed Judiciary and Fiscal Policy, to this bill. Amends provisions relating to debtors and creditors; establishes a statutory framework for

perfecting and prioritizing claims of judgment liens on personal property by replacing the current system of county-by-county filing with a statewide centralized filing database.
