point of Section 36; thence run along the south line of the 1 northeast guarter of Section 36 at a bearing of South 87 2 3 degrees, 44 minutes, 10 seconds East, a distance of 1,565.04 feet to a point; thence run North 0 degrees, 1 minute, 8 4 5 seconds East, a distance of 999.33 feet to a point of б curvature; thence continue in a northerly and northeasterly 7 direction along the arc of a circle to the right, with a 8 radius of 490.69 feet, a central angle of 30 degrees, 17 minutes, 5 seconds, for an arc distance of 259.36 feet to a 9 10 point; thence run South 87 degrees, 45 minutes, 26 seconds 11 East along a line for a distance of 1,010.75 feet to a point on the east line of Section 36; thence run southwardly along 12 the east line of Section 36 a distance of 2,570.41 feet, more 13 or less, to the Point of Beginning. 14 Section 3. All real property the title to which is 15 vested in Dade County and which is located within the area 16 17 comprising Hialeah County is transferred to Hialeah County on the effective date of this act. Personal property the title to 18 19 which is vested in Dade County is transferred to Hialeah County on the effective date of this act in an amount equal to 20 the proportion which the assessed value of taxable property in 21 the area comprising Hialeah County bears to the assessed value 22 of taxable property in Dade County as of the previous January 23 24 1. Hialeah County shall assume responsibility for the obligations of Dade County which exist on the effective date 25 of this act in an amount equal to the proportion which the 26 27 assessed value of taxable property in the area comprising Hialeah County bears to the assessed value of taxable property 28 29 in Dade County as of the previous January 1. 30 Section 4. Notwithstanding any other provision of law, the Board of County Commissioners of Dade County shall call 31
