**I. SUMMARY:**

This legislation re-creates the Design and Construction Trust Fund without modification, effective November 4, 2000. The Design and Construction Trust Fund, FLAIR #50-2-771, is administered by the Department of Veterans' Affairs. This fund was last re-created effective November 4, 2000, by Chapter 96-131, Laws of Florida.
