**I. SUMMARY:**

This legislation re-creates the Library Services Trust Fund without modification, effective November 4, 2000. The Library Services Trust Fund, FLAIR #45-2-450, is administered by the Department of State. This fund was last re-created effective November 4, 1996, by Chapter 96-48, Laws of Florida.

The House substituted SB 624 for HB 1401 prior to final passage on March 15, 2000.

**II. SUBSTANTIVE ANALYSIS:**

**A. PRESENT SITUATION:**

**1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:**

No reference in statutes.

**2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:**

The fund serves as a repository for federal funds which are disbursed in the form of library grants.

**3. MAJOR SOURCES OF REVENUE FOR THE FUND:**

The major sources of revenue for the fund are receipts from the federal Library Services and Construction Act, Public Law 101-254. According to Comptroller data, receipts to this fund for FY 1998-99 were \$7,091,553.18.

**B. EFFECT OF PROPOSED CHANGES:**

This bill re-creates the trust fund without modification.

III. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT:

This legislation has no fiscal impact on state agencies or state funds, on local governments as a whole or on the private sector. It simply re-creates, without modification, an existing state trust fund and continues the current use of the fund.
