I. SUMMARY:

This legislation re-creates the Historical Resources Operating Trust Fund without modification, effective November 4, 2000. The Historical Resources Operating Trust Fund, FLAIR #45-2-510, is administered by the Department of State. This fund was last re-created effective November 4, 1996, by Chapter 96-75, Laws of Florida.

The House substituted SB 630 for HB 1407 prior to final passage on March 15, 2000.

A. PRESENT SITUATION:

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund is used for operational support of historical resources programs.

The major sources of revenue for the fund are federal funds as well as loans, donations, endowments, and other gifts. According to Comptroller data, receipts to this fund for FY 1998-99 were \$5,9000,670.62.

This bill re-creates the trust fund without modification.
