I. SUMMARY:

This legislation re-creates the Records Management Trust Fund without modification, effective November 4, 2000. The Records Management Trust Fund, FLAIR #45-2-572, is administered by the Department of State. This fund was last re-created effective November 4, 1996, by Chapter 96-84, Laws of Florida.

The House substituted SB 636 for HB 1413 prior to final passage on March 15, 2000.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 257.375, F.S., creates the trust fund, provides revenue source for the fund, and defines the uses of the fund.

Section 257.36, F.S., provides a revenue source for the fund.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund is used to support the programs of the state archives and records and information management programs.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue are fees collected for records management and archival services. According to Comptroller data, receipts to this fund for FY 1998-99 were \$1,462,737.03.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.

III. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT:

This legislation has no fiscal impact on state agencies or state funds, on local governments as a whole or on the private sector. It simply re-creates, without modification, an existing state trust fund and continues the current use of the fund.
