I. SUMMARY:

This legislation creates the Digital Divide Trust Fund. The Digital Divide Trust Fund would be administered by the Office of Information Technology in the Executive Office of the Governor (i.e., the State Technology Office).

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

HB 1045 would create the substantive statute that would control the administration of the Digital Divide Trust Fund.

BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The Digital Divide Trust Fund would be used, pursuant to the provisions of related HB 1045 or similar legislation, to provide access to information technology through the education system. Trust funds would be used to upgrade and purchase information technology for classrooms, train educators on using technology in the classroom and purchase information technology devices for use by students both at school and at home.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The primary source or revenue for the fund would be appropriations. However, contributions could also be made by private entities seeking to establish public-private partnerships with the state for the purpose of enhancing student achievement.

B. EFFECT OF PROPOSED CHANGES:

This bill creates the Digital Divide Trust Fund.
