8 (2) The names of the candidates placing first and 9 second in the first primary election shall be placed on the 10 ballot in the second primary election for each contest in 11 which no candidate <u>was declared to be nominated pursuant to s.</u> 12 <u>100.061</u> receives a majority of the votes cast in the first 13 primary election, subject to the following exceptions:

(a) In any contest in which there is a tie for first
place in the first primary election, only the names of the
candidates so tying shall be placed on the ballot in the
second primary election.

(b) In any contest in which there is a tie for second place in the first primary election and the candidate placing first was not declared to be nominated pursuant to s. 100.061 did not receive a majority of the votes cast, the name of the candidate placing first and the names of the candidates tying for second shall be placed on the ballot in the second primary election.

(3) The candidate who receives the highest number of votes cast for the office in the second primary election shall be declared nominated. In case two or more persons receive an equal and highest number of votes for the same office in the second primary, such persons shall draw lots to determine who will receive the nomination.
