## I. Summary:

This bill deletes a requirement that persons requesting an absentee ballot provide either all or part of their social security number to the supervisor of elections. The bill also deletes a requirement that electors provide the last four digits of their social security number on the absentee ballot Voter's Certificate.

This bill substantially amends the following sections of the Florida Statutes: 101.62, 101.64, 101.65, and 101.68.

### **II.** Present Situation:

Electors requesting an absentee ballot must provide the last four digits of their social security number. Section 101.62(1)(b), F.S. Eligible third parties (immediate family members and legal guardians) requesting an absentee ballot for an elector must provide their full social security number.

In addition, Florida law provides that electors must include the last four digits of their social security number on the absentee ballot Voter's Certificate, or their ballot will not be counted. Section 101.64(1), 101.65, 101.68(2)(c)1., F.S. The U.S. Department of Justice, however, refused to "preclear" changes to the Voter's Certificate, pursuant to the Voting Rights Act of 1965. Therefore, the requirement that voters include the last four digits of their social security numbers on the Voter's Certificate, and conforming changes to the Florida Election Code, have never taken effect.

All of these provisions were adopted as part of the 1998 Voter Fraud Act, in response to problems highlighted in the Miami mayoral race of 1997.
