I. Summary:

This bill provides it is unlawful to sell, manufacturer, or deliver any blank, forged, stolen, fictitious, counterfeit, or unlawfully issued driver's license or similar document without approval by the Department of Highway Safety and Motor Vehicles. Violation of this provision would constitute a second degree felony punishable by a term of imprisonment of 15 years and a \$10,000 fine.

This bill substantially amends section 322.212 of the Florida Statutes.

II. Present Situation:

Section 322.212, F.S., provides it is unlawful for any person to possess or to display any blank, forged, stolen, fictitious, counterfeit, or unlawfully issued driver's license or identification card or any instrument in the similitude of a driver's license or identification card. Similarly, this section provides that is unlawful for any person to have in his or her possession any instrument in the similitude of a driver's license issued by the Department of Highway Safety and Motor Vehicles or its duly authorized agents for the purpose of operating a motor vehicle. Violation of this section is punishable as a third degree felony (5 years imprisonment and \$5,000 fine). However, anyone who provides a false age in an application or who possesses a driver's license, identification card, or similar document on which the date of birth has been altered is guilty of a misdemeanor of the second degree.

While current law addresses the possession or display of specified documents, there is no provision in statute that addresses the sale, manufacture, or delivery of such documents.

III. Effect of Proposed Changes:

This bill amends s. 322.212, F.S., to provide it is unlawful to sell, manufacturer, or deliver any blank, forged, stolen, fictitious, counterfeit, or unlawfully issued driver's license or similar document without approval by the Department. Violation of this section would constitute a second degree felony punishable by a term of imprisonment of 15 years and a \$10,000 fine. The bill also provides that violations may be investigated by any state agency, including, the Division of Alcoholic Beverages and Tobacco.
