I. SUMMARY:

This legislation creates the Local Communications Services Tax Trust Fund. The Local Communications Services Tax Trust Fund will be administered within the Department of Revenue. This legislation provides for its sources of moneys and purposes and for annual carryforward of fund balances. It provides that the trust fund is exempt from constitutional termination.

On April 17, 2001, the Committee on Fiscal Policy & Resources adopted an amendment which specifies HB 1889 as the tied bill, and reported the bill as a committee substitute.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

Section 202.18, Florida Statutes.

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The Local Communications Services Tax Clearing Trust Fund is to be used for distribution of the proceeds to the municipalities and counties. Moneys deposited in the trust fund are exempt from the service charges imposed under s. 215.20. Any balance in the Local Communications Services Tax Clearing Trust Fund at the end of any fiscal year shall remain in the trust fund at the end of the year and shall be available for carrying out the purposes of the trust fund.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

Proceeds from the tax levied by municipalities and counties pursuant to section 202.19, Florida Statutes.
