However, the requirements imposed by s. 290.0055(4)(d) do not apply to such satellite enterprise zone areas. Section 2. Satellite enterprise zones may be created pursuant to s. 290.00555, Florida Statutes, effective retroactively to December 31, 1999. Any sales and use taxes paid within such a zone during the period beginning December 31, 1999, and ending on the date of the creation of the zone which would have been eligible for the exemptions or credits granted by ss. 212.08(5)(g) and (h) and (15) and 212.096, Florida Statutes, shall be recoverable only as a refund as provided in s. 215.26, Florida Statutes. It is the intent of the Legislature that this act be deemed remedial in effect. Section 3. This act shall take effect upon becoming a law.
