the organization's budget, which shall be subject to approval by the university president.

- university may appoint a representative to the board of directors and the executive committee of any university health services support organization established under this section. The president of the university for which the university health services support organization is established, or the president's designee, shall also serve on the board of directors and the executive committee of any university health services support organization established to benefit that university.
- organization shall make provisions for an annual postaudit of its financial accounts to be conducted by an independent certified public accountant in accordance with rules of the board of regents of a state university. The annual audit report shall include a management letter and shall be submitted to the Auditor General and the board of regents for review. The board of regents of a state university and the Auditor General may shall have the authority to require and receive from the organization or from its independent auditor any detail or supplemental data relative to the operation of the organization. The auditor's report, management letter, and any supplemental data requested by the board of regents of a state university and the Auditor General shall be considered public records, pursuant to s. 119.07.
