# I. Summary:

The Division of Statutory Revision of the Office of Legislative Services is required, by statute, to conduct a systematic and continuing study of the Florida Statutes. The purpose of this study is to recommend to the Legislature changes that will remove inconsistencies, redundancies, and unnecessary repetition from the statutes; improve clarity and facilitate correct interpretation; correct grammatical and typographical errors; and delete obsolete, repealed, or superseded provisions. These recommendations are submitted to the Legislature in the form of technical, nonsubstantive reviser's bills.

This is a general reviser's bill, covering volume 4 of the Florida Statutes, to delete expired or obsolete language; correct cross-references and grammatical or typographical errors; remove inconsistencies and redundancies from the statutes; improve the clarity of the statutes and facilitate their correct interpretation; and confirm the restoration of provisions unintentionally omitted from republication in the acts of the Legislature during the amendatory process. A reviser's bill cannot be amended except to delete a bill section.

This bill substantially amends or repeals the following sections of the Florida Statutes: amends ss. 470.016, 471.025, 472.001, 472.003, 472.005, 472.011, 472.015, 472.021, 472.025, 472.027, 472.031, 472.037, 476.024, 494.0017, 498.025, 499.015, 499.03, 499.05, 501.34, 514.0231, 519.101, 527.01, 527.02, 538.11, 550.6305, 550.904, 550.912, 553.381, 553.507, 553.902, 569.11, 570.21, 576.045, 589.065, 597.003, 597.0041, 607.1901, 617.1622, 620.8101, 620.9901, 626.112, 626.621, 626.6215, 626.797, 626.844, 626.8734, 626.909, 626.9911, 626.99275, 627.031, 627.062, 627.351, 627.357, 627.481, 627.6487, 627.6699, 627.6735, 627.736, 627.9403, 627.9407, 627.94072, 627.944, 628.909, 631.718, and 631.911; and repeals ss. 489.1136(1)(g), 499.005(26), 550.2633(3) and (4), 624.408(1)(b)1., and 627.0661.

#### VIII. Amendments:

### #1 by Rules & Calendar:

This amendment removes from the reviser's bill the amendment to s.519.101(1),F.S. The removed provision would delete a reference to the Department of Commerce providing advice on specified aspects of a study on Florida equity exchanges. It is being deleted because it is possible that the Office of Tourism, Trade, and Economic Development may be performing the functions here that used to be performed by Commerce, and substitution of a reference to OTTED for the reference to Commerce instead of deleting the cite to Commerce may be appropriate. (WITH TITLE AMENDMENT)

### #2 by Rules & Calendar:

This amendment removes from the reviser's bill the amendment to s.550.6305(9)(a) and (g). The removed provision would have deleted material citing to a repealed section. It is being deleted because the material formerly in the cited repealed section is now elsewhere and the cite needs to be updated to refer to the new location through substantive legislation. (WITH TITLE AMENDMENT)

### #3 by Rules & Calendar:

This amendment removes from the reviser's bill the amendment to s.627.351(2)(b)6., (5)(a)9. The removed provision would have updated numerical cross-references. It is being deleted because the cite is incorrect and needs to be corrected through substantive legislation. (WITH TITLE AMENDMENT)
